The Multiple Crises Facing Africa

Fall-out from the Ukraine Crisis

 Soaring wheat and oil prices have drastically impacted food and energy supply for the people and economies of Africa

Covid-19

- Economic fallout has pushed 40 million people into extreme poverty
- Low vaccination rates hinder growth recovery
- Limited resources for financial assistance to households and firms

Climate change

- African nations highly vulnerable to extreme weather, e.g. droughts.
- Risk of income loss and food insecurity due to large share of weathersensitive activities in African national GDPs and employment (e.g. agriculture, herding and fishing)
- 95% of rain-fed agriculture globally is in sub-Saharan Africa





Why Africa Matters to the World

- Social and economic stability of Africa is critical for global prosperity
 - Potential large-scale provider of food, energy and natural resources
 - Largely untapped frontier for business (a big market)
 - Africa's young, growing population ("youth bulge") must be empowered economically, socially and politically
 - Poverty creates breeding ground for disease, crime and extremism
- Africa has over one quarter of the seats in the UN and is a vital actor to foster international solidarity to respect peace, liberty, democracy, and human rights
- Africa lags behind in achieving SDGs

Free and Open Indo-Pacific

"Diplomacy that takes a panoramic perspective of the world map"

Free and Open Indo-Pacific

A key for stability and prosperity of the international community is dynamism that is created by combining

"Two Continents": Asia that is rapidly growing and Africa that possess huge potential of growth; and

"Two Oceans": Free and open Pacific Ocean and Indian Ocean

⇒ broaden the horizon of Japanese foreign policy by envisioning the above as an overarching, comprehensive concept

Africa

- Full of potential
- population around 1.3 billion (17% of global population)
 → around 2.5 billion in 2050
- account for 30,000,000 km²
 (22% of global area)
- high economic growth rate (4.8% on average (2000-2016))
- rich in natural resources and promising markets
- ⇒ progressing as a "developing continent" whereas still facing challenges including by poverties and terrorism.

Japan will provide nation-building support in the area of development as well as politics and governance, in a way that respects the ownership of African countries, and not by forcing on or intervening in them.

◆ The Indo-Pacific region is facing various challenges such as piracy, terrorism, proliferation of WMD, natural disasters and attempts to change the status quo. Under such circumstances, Japan aims to promote peace, stability and prosperity across the region to make the Indo-Pacific free and open as "international public goods", through ensuring rules-based international order including the rule of law, freedom of navigation and overflight, peaceful settlement of disputes, and promotion of free trade.



<u>Asia</u>

- Increase of awareness of confidence, responsibility and leadership, as well as democracy, the rule of law and market economy taking root in ASEAN and South Asian countries
- ⇒ Currently expanding its success to Africa and bring out the potential of Africa as a "global main player" through a free and open Indo-Pacific.

Japan will further promote quality infrastructure development, trade and investment, and enhance business environment and human development, strengthening connectivity in ASEAN region.

Japan will expand ASEAN's success to other regions such as the Middle East and Africa.







Signing of a loan agreement to support COVID-19 responses in Africa (Private Sector Investment and Finance)

Contributing to strengthening Africa's healthcare sector including support to COVID-19 vaccine manufacturing in the continent

On March 30, the Japan International Cooperation Agency (JICA) signed a loan agreement of up to \$200 million with the African Export-Import Bank (Afrexim) to support COVID-19 responses through Private Sector Investment and Finance. The Ioan will be co-financed with the Sumitomo Mitsui Banking Corporation (SMBC) and Mitsubishi UFJ Financial Group (MUFG) (*1).

COVID-19 pandemic has significantly affected the entire African continent. Social and economic activities have been hindered due to the pandemic, which in 2020 resulted in its worst historical GDP growth rate, recording negative 1.7% in Sub-Saharan Africa (source: IMF) and negative 1.1% in North Africa (source: African Development Bank). In order to recover smoothly from the pandemic, provision of health and medical services, including COVID-19 vaccination, is essential. Also, COVID-19 revealed that Africa lacks medical and pharmaceutical products as well as infrastructure such as hospitals, and Africa's healthcare system is quite fragile (*2). Thus, strengthening the healthcare system is critical for Africa.



Signing ceremony

Afrexim is a multilateral financial development institution which has 51 member states in Africa. It has been supporting Africa in mitigating the impact of COVID-19 since it broke out, and will deploy the loan to advance the development of local production capacities for vaccines and medical products, with the overarching ambition to promote the self-reliance of African countries in their response to the pandemic and reduce their dependence on non-African products and international supply chains.

JICA's loan will be used to manufacture medical and pharmaceutical products including vaccine manufacturing lines, development of supply bases for those products, and development of medical and health facilities such as hospitals, through Afrexim. It will also mobilize Japanese commercial banks' capital within the continent. This will lead to creation of a stronger healthcare system as well as smoother recovery of social and economic activities from COVID-19. It is also aligned with Sustainable Development Goal 3 (Good health and well-being), Goal 9 (Industry, innovation and infrastructure), and Goal 17 (Partnerships for the goals).

(*1) The SMBC-JICA Sustainable Finance Framework, which was launched on March 30, 2021, will be applied to this loan agreement. SMBC's loan will also be used for social and economic recovery from COVID-19 in Africa.

(*2) Africa heavily relies on imported vaccines, where 99% of vaccine doses (COVID-19 vaccines, flu vaccines, and others) are imported.

Home-Grown Solutions Accelerator Program

Expanding home-grown solutions for pandemic resilience by creating a platform and providing business consultation





- Initiated by AUDA-NEPAD in 2020 at the onset of the pandemic
- Supported five selected companies from the East Africa Community (EAC) as a pilot, and expanding to the continent level to partner with 10-15 companies
- REVITAL, a Kenyan manufacturer of essential medical supplies and consumables, succeeded in receiving \$7 million in investment

CARD (Coalition for Africa's Rice Development)

Doubling rice production in sub-Sarahan Africa using a climate resilience-focused approach

- Launched at TICAD4 (2008)
- Succeeded in doubling rice production in Sub-Saharan
 Africa over 2008-2018 to 28 million metric tons
 - ➤ 48 projects in 17 countries (a total value of JPY56 billion)
 - Trained 1400+ African experts
- Renewed at TICAD7 (2019)
 - ➤ New target: doubling rice production in sub-Saharan Africa over 2019-2030 to 56 million tons
 - "RICE" (Resilience, Industrialization, Competitiveness, Empowerment) approach
 - ➤ 32 CARD member countries could potentially be self-sufficient rice producers.

- Internet economy in Africa could expand to \$180 billion by 2025, up from \$115 billion in 2020, on the back of improved connectivity, a growing talent pool, rapidly growing urban population and economic integration (source: IFC).
- African startups are pushing innovation in fintech, healthtech, media and entertainment, e-commerce, e-mobility, and e-logistics


